THE LIBERUM ASSOCIATION INFORMS that, through the investigation carried out by the **LEGAL TEAM**, regarding batches of COVID-19 vaccines, reported anonymously by citizens during the months of October to December 2022, we were able to prepare a DOSSIER of 6,450 pages with the main lots that were reporting to us the partners and citizens in general who, **had suffered a serious adverse effect or sadly, death.**

After completing the investigation and drawing up the conclusions of the DOSSIER, we selected a total of **SEVENTEEN LOTS** of **the Pfizer** (14) and Moderna (3) vaccines for having a <u>HIGH LEVEL OF TOXICITY</u> (SERIOUS ADVERSE EFFECTS + DEATHS) REPORTED TO VAERS¹. Thus LEGAL TEAM evacuatedor different writings and requests through the channels of TRANSPARENCY to the SPANISH AGENCY OF MEDICINES AND HEALTH PRODUCTS and the GENERAL DIRECTORATE OF PUBLIC HEALTH.

Thanks to these requests, we have managed to know the total number of lots acquired by Spain, 469 until mid-February 2023 that represent around 217,000,000 million vaccines of which only 107,000,000 million **had been inoculated with a difference of almost 100,000,000 million that** we do not know where they are. It was also known that Spain receives funding from the EU, through FUNDS and REIMBURSABLE LOANSthrough the NEW GENERATION economic mechanism.

THE SURPRISE CAME YESTERDAY, MARCH 1, 2023 WHEN WE RECEIVED AN OFFICIAL RESPONSE FROM THE AEMPS WHERE WE WERE TOLD THAT THE DECEASED AND THE SERIOUS ADVERSE EFFECTS OF THE LOTS, ONLY OF PFIZER

(14), REACHED 199 DEATHS AND 2,326 SERIOUS ADVERSE EFFECTS.

That is, with only 14 batches (of 469) there have been almost half of the deaths that the AEMPS reports in its F armacovigilance reports (500) and 22% of all serious adverse effects (14,003²).

Con fecha 13 de febrero de 2023, tuvo entrada en Agencia Española de Medicamentos y Productos Sanitarios su solicitud de acceso a la información pública al amparo de la Ley 19/2013, de 9 de diciembre, de transparencia, acceso a la información pública y buen gobierno [en adelante, LTAIBG].

Una vez analizada la solicitud, la Dirección de esta Agencia resuelve CONCEDER el acceso a la información solicitada en el ámbito de sus competencias y, en consecuencia, informa de lo siguiente en atención a cada uno de las preguntas planteadas:

1.- Se informe de cuantos reportes ES-AEMPS constan en las bases de datos de la AEMPS de cada uno de los lotes especificados, dividiendo por lote cada reporte.

En la tabla 1 (incluida más abajo), se incluye el número de los casos de acontecimientos adversos notificados tras la administración de la vacuna frente a la COVID-19 de Pfizer (Comirnaty) a fecha de 15 de febrero de 2023.
